Whereas by the will in writing which I have given and devised to my Nephew James Monteth and his heirs all the rest and residue of my lands tenements and hereditaments in Kent or elsewhere in the Kingdom of England. Now I the said Francis Monteth do hereby in the fourth day of September in the year of Our Lord One thousand six hundred eighty six by my the same day that my said Will is made, declare that my Will and meaning is, and I do hereby devise that my said Nephew James Monteth and his heirs shall have and enjoy all and every the Reversion and residue remainder and remainder expectant upon the decease of my loving wife of all and every the mesuages lands and tenements that I have settled upon her for her furniture or given her by my said Will. In witness whereof I have hereunto set my hand and seal the day & year abovesaid. Fran. Monteth. Read before the said Francis Monteth, & then sealed and published by him as a Codicill in the presence of Thomas Short. John Jackson. Rob. Eccleston. Thomas Stebbins.

Esq. being of perfect mind and memory, blessed be God do make and ordain in this my last Will and Testament in manner and forme following, first I commit my Soul to the hands of Almighty God my Creator, and my body I commit to the Earth from whence it came, to be orderly and decently buried, trusting and believing that through the merits of Jesus Christ my only Lord and Saviour I shall have a joyfull resurrection, and be eternally saved; And as for that temporal estate which God hath been pleased to bless me with: I dispose of the same as followeth: first I give and bequeath to my dear wife Barbara Mordaunt widow my sole Executrix of this my last Will and Testament all and singular my Goods Cattle Chattels and personal estate

to her.

 bequests and legacies herein after mentioned: first I give and bequeath unto
 my Aunt S. George a Guiney to buy her a mourning Ring: Item I give and
 bequeath unto my Mother in Law m^{rs} Barbara Ludlow five pounds to buy
 her Cloath for a mourning Gowne: Item I give and bequeath the summe
 of five pounds amongst those servants who shall have at the time of
 my death, to be distributed at the discretion of my said Executrix: I doe
 alsoe appoint that Elizabeth Bryan who now dwelleth in my house with me
 and maintained by me shall be doe maintained and provided for during the
 life at the joynt charges of my said Executrix and my selfe Henry
 Mordeant who is my s^{on} at Law, And if shee dye at the charges of him
 who shall be the next Heire: And that my said Executrix may be the
 better encouraged to see my Children well educated and provided for I give
 and bequeath to her and her s^{on} for ever (over and above her jointure
 already settled by Deed) the five Acres of Meadow lately purchased of
 Henry Neville Esq^r: And I doe appoint her to be Guardian over my said s^{on}
 Henry until shee come to Eighteen yeares of age: In witness whereof I have
